### OVERVIEW

- *Tenaga Nasional Berhad v Energy Commission & the Minister of Energy, Green Water & Technology* – This judicial review application before the High Court related to the decision of the Energy Commission and the Minister of Energy, Green Water & Technology in directing Tenaga Nasional Berhad to enter into a commercial agreement with YTL Power Generation Sdn Bhd and abandon its commercial position with the said party (led by Tan Sri Dato' Cecil Abraham and Rishwant Singh).
- *Tun Hussein Onn National Eye Hospital v Megat Nor Ishak Bin Megat Ibrahim & Ors* – This appeal that is pending before the Federal Court relates to the law of vicarious liability of private hospitals and the doctrine of non-delegable duty, in respect of which the Association of Private Hospitals of Malaysia has been granted leave to intervene to address the apex court on these key issues (led by Tan Sri Dato' Cecil Abraham and Sunil Abraham).
- *Zulhasnimar Binti Hassan Basri & Anor v Dr Kuppu Velami & Ors* – This appeal relates to the duty of care of doctors and private hospitals generally, in respect of which the Association of Private Hospitals of Malaysia has been granted leave to intervene to address the apex court on these key issues. The Federal Court has in this decision clarified the Malaysian position vis-à-vis the distinction must between diagnosis and treatment of a patient on the one hand and the duty to advise a patient of risks on the other hand (led by Tan Sri Dato' Cecil Abraham and Sunil Abraham).



## OVERVIEW

- Ernst & Young v AmTrustee Berhad & Ors – This is a pending dispute before the Court of Appeal concerning the law of professional negligence applicable to accountants, the application of statutory duties imposed on accountants as well as the width and ambit an important notice in an information memorandum is to apply to sophisticated investors in acquiring bonds on the open market (led by Tan Sri Dato' Cecil Abraham and Sunil Abraham).
